Sealed bids for the Project known and identified as: "Florida City Community Redevelopment Agency (CRA) NW 1<sup>st</sup> St-NW 2<sup>nd</sup> St Area Roadway Improvements" will be received by the CRA, Attention: City Clerk, 404 West Palm Drive, Florida City, Florida 33034 until **1:45 p.m. local time September 7, 2017**. Any bid received after 1:45 p.m. shall not be considered. The bids will be publicly **opened and read aloud at 2.00 p.m., September 7, 2017** in the Florida City Commission Chambers.

The project consists of reconstructing-regrading-milling and resurfacing NW 1<sup>st</sup> St and NW 2<sup>nd</sup> St from NW 3<sup>rd</sup> Ave to NW 7<sup>th</sup> Ave, NW 3<sup>rd</sup> Ave and NW 7<sup>th</sup> Ave from W. Palm Drive to NW 2<sup>st</sup> St and NW 5<sup>th</sup> Ave-NW 6<sup>th</sup> Ave from NW 1<sup>st</sup> St to NW 2<sup>nd</sup> St. The reconstruction will include reworking the lime rock base, repaving, milling and resurfacing, constructing curb and gutter and drainage improvements as required. The improvements also include new concrete and asphalt driveways, handicap ramps, concrete sidewalks (as required), and landscape improvements.

All bids must be submitted in sealed envelopes bearing on the outside the name of the Bidder, his address, the name of the project for which the bid is submitted, and the date of opening. No bidder may withdraw his bid within ninety (90) days after the date set for the opening hereof. A Bid Bond in the amount of 5% of the bid is required to be submitted with the bid. Upon award of the contract, Performance and Payment Bonds in the amount of 100% of the contract award amount shall be required.

A mandatory Pre-Bid Meeting is scheduled for **Friday, August 18th, 2017 at 9:30 a.m.** in the Commission Chambers at City Hall located at 404 West Palm Drive, Florida City, Florida, 33034.

Bids from any person, firm, or corporation in default on other contracts or agreements with the CRA or the City shall be rejected. Failure by the Bidder to satisfy claims on previous contracts with the CRA or City shall be cause for rejections.
