Sealed bids for the Project known and identified as: "Florida City Community Redevelopment Agency (CRA) Lucy Street Shops Infrastructure Improvements" will be received by the CRA, Attention: City Clerk, 404 West Palm Drive, Florida City, Florida 33034 until 1:45 p.m. local time January 15, 2016. Any bid received after 1:45 p.m. shall not be considered. The bids will be publicly opened and read aloud at 2.15 p.m., January 15, 2016 in the Florida City Commission Chambers.

The project consists of demolishing existing concrete structures, relocating existing water and sanitary sewer improvements and appurtenances pertaining to the properties at 103-135 Lucy Street in Florida City. The improvements will also include the installation of a new fire line and its connection to the existing Fire Department Connections and Building Lines. The scope of work also includes the removal of the existing royal palms and landscape improvements.

No bidder may withdraw his bid within ninety (90) days after the date set for the opening hereof. A Bid Bond in the amount of 5% of the bid is required to be submitted with the bid. Upon award of the contract, Performance and Payment Bonds in the amount of 100% of the contract award amount shall be required.

A mandatory Pre-Bid Meeting is scheduled for Friday, December 11, 2015 at 10:00 a.m. in the Commission Chambers at City Hall located at 404 West Palm Drive, Florida City, Florida, 33034.

Bids from any person, firm, or corporation in default on other contracts or agreements with the CRA or the City shall be rejected.
